

# Information Packet and Nomination Form for the Glenn J. Winuk Humanitarian Service Award



The **Glenn J. Winuk Humanitarian Service Award** is presented annually by the Tallahassee office of the law firm **Holland & Knight** and in partnership with **Leon County Government** to honor the memory of a former partner, with the support and cooperation of the Winuk family. The award is presented to honor acts of sacrificial service that Glenn Winuk exemplified in his life and in his death at the World Trade Center on September 11, 2001. The 2017 winner will be recognized at a formal ceremony held on Monday, September 11, at 11 a.m. in the Florida State University College of Law Rotunda, 425 West Jefferson Street.

## The Story Behind the Glenn J. Winuk Humanitarian Service Award

On the morning of September 11, 2001, when terrorists attacked the World Trade Center, Glenn J. Winuk, a 40-year-old partner at Holland & Knight, sprang to action. As a boy, Glenn dreamed of being a firefighter and saving lives. “He was one of those kids that would go chasing through the neighborhood after fire trucks,” said Glenn’s brother, Jay S. Winuk. Glenn realized his dream by serving as a volunteer firefighter and EMT in his hometown on Long Island for almost 20 years.

Upon learning of the attacks on the morning of September 11, Glenn raced from his midtown apartment to Holland & Knight’s New York City office, located just two blocks from the Twin Towers. He helped evacuate the firm’s law office, borrowed a first responder’s medic bag from workers on the scene and rushed into the towering inferno that was the South Tower to save lives. People were in need of emergency medical care and Glenn responded quickly and courageously. Six months later, his partial remains were discovered. He was donning surgical gloves and a stethoscope, a medic bag by his side. Glenn was posthumously awarded the 9/11 Heroes Medal of Valor by President Barack Obama and the United States Department of Justice.

The boy who chased fire trucks became the man whose service can only be described as heroic. Our country is a beacon of hope because of people like Glenn Winuk, whose actions and story helped inspire the “9/11 National Day of Service and Remembrance” (911day.org). When stories of heroes are told, others are inspired to accomplish deeds of kindness. On the 10th anniversary of the 9/11 attacks, a record 33 million people engaged in charitable service and good deeds.

Today is your opportunity to nominate someone you revere for this prestigious award so that his or her service can be recognized.

# General Information

## 1. Who is this award for?

**The Glenn J. Winuk Humanitarian Service Award is for those who render sacrificial service for the benefit of others.** Sacrificial service was the hallmark of Glenn's life. Indeed, his final act of courage on September 11, 2001, followed nearly 20 years of putting his life on the line as a volunteer firefighter and EMT. The award is not limited to those who run into burning buildings to save lives. Instead, it is much broader and extends to anyone who demonstrates sacrificial service. Both one-time heroic acts as well as years of sacrificial service are eligible for the award. We will be primarily focused on activities that have occurred since September 11, 2016, but we also welcome the inclusion of activities from prior to that date. Glenn lost his life on 9/11 while serving, and that day 9/11 has now become a National Day of Service. The 2017 Glenn J. Winuk Humanitarian Service Award will be presented in Tallahassee, FL, on Monday, September 11, at the Florida State University College of Law to recognize local heroes who carry forward the tradition of humanitarian service exemplified by Glenn's life. This award will also include a \$1,000 donation to the charity of the winner's choice. We encourage prior applicants to submit an application for the award. Prior winners are ineligible.

## 2. Selection process

All nominations will be reviewed and ranked by a selection panel assembled by the Tallahassee office of Holland & Knight and other community partners.

## 3. Nomination deadline: August 18, 2017

Completed nomination applications will be accepted beginning on Monday, July 10, 2017. In order to be considered, a nomination application must be received (not just postmarked) by 5:00 p.m. EST on August 18, 2017.

## 4. Application instructions

The two-page nomination form must be filled out completely. The information submitted on a nomination form will be used for the purpose of evaluating each nominee and for furthering the purpose of the award. Nominations may be submitted by email or mail.
