Located in the Hycrest Farms subdivision – In township and section 16-32, 1N 3E – **Hycrest Ln** – this project was withdrawn by the applicant and is no longer being tracked as an approved development. Please, delete it from your tracking systems.

Not located in a subdivision - In township 31-02, 1S 1E. **Rabitaile Ln** – this roadway now services only one dwelling and therefore has been rescinded effective immediately. Please delete this street name from your tracking systems.




